** AECC may use Point-to-Point transmission service in conjunction with the AECC / Entergy Arkansas Power Coordination, Interchange, and Transmission Service Agreement (PCITSA) to deliver all planned, owned/contractually secured resources to meet the firm-service requirements of AECC's native load obligations. Purchased resources or owned generation located outside Entergy Arkansas' transmission system may use Point-to-Point transmission service if they are designated in the load and capability plans for AECC member loads utilized in the joint planning activities between Entergy - Arkansas and AECC. For cross-system transactions involving AECC (e.g., simultaneous buy-sell, wheeling, etc.), Point-To-Point Service must be purchased under the Entergy tariff.
