And because there's some strict deadlines in there, um, I guess, that's something we will have to wait for, uh, for you to--because depending on the outcome of the report obviously, we would be forced to appeal if we have, uh, continued concerns. So, um, I guess, rather than ask the question, I'll just follow-up and say that we'll, um, we'll presume that we'll have those discussions at that point when we cross that bridge when we come to it.

So, uh, what my expectation would be is at the end, once the GM certificate is issued at that step of the process, then we'll, we'll provide some more clarity in terms of what any, um, dispute associated with that GM certificate would be.

But we've got a lot of steps between now, now and then and decisions have not been made yet by either party, um, I mean, by any of the stakeholders or LADWP. Uh, it's important to remember right now that the, um, the consulting team has read the initial proposal on the table and that initial proposal is what all stakeholders are reviewing and, uh, the stakeholders are--have been asking data requests and then have the ability to submit comments.

Um, once those comments are received, uh, the consulting team is going to be looking at all those comments in relation to what the original proposal was and evaluating, uh, did we miss anything. Uh, and, and what's really important is that this is recent decision-making that's going on so it's, um, not just from stakeholders saying we disagree but why. And then, the consulting team will think about that and determine at what point, what is the final recommendation that is being made to management.

Then management will then make that recommendation to the GM and the GM will consider all the information. So, I, I, I do get a little sense that the--it looks like DWP has a rigid, unmoving proposal. That's not what this process is all about. Um, it really is designed to hear from stakeholders, what are they thinking and why. And so, what we end up with that, when we get to that GM certificate, that GM certificate, there will be a lot of considerations that will have gone on in, in terms of what the GM ultimately makes, the GM will explain what his decisions are.

And at that point, uh, the business practice does allow for a dispute resolution of the GM certificate. Uh, there are (STAMMERS) we can't change the processes that are in the business practice but what we can do is if there are questions about what is, um, the details of how it would be implemented, we can work through those, uh, as, after the, uh, GM certificate is issued or simultaneously with it.

And then on April 14th is the last day for stakeholders to, to submit comments to be review for, uh, reviewal and then after that, we will have May 4th which is what we talked about, the GM certification will occur.
