

## Request for Login Access to LG&E/KU CEII Transmission Information

The below form is intended to facilitate requests for access to LG&E/KU transmission information containing Critical Energy Infrastructure Information (CEII). As LG&E/KU protects its information containing CEII, access is limited to individuals who have executed a Non-Disclosure Agreement (NDA) and submitted this request for login access to a secured FTP site.

The Federal Energy Regulatory Commission (FERC) has defined CEII as “specific engineering, vulnerability, or detailed design information about proposed or existing critical infrastructure that: (1) relates details about the production, generation, transportation, transmission, or distribution of energy; (2) could be useful to a person in planning an attack on critical infrastructure; and (3) gives strategic information beyond the location of the critical infrastructure.”

The information included on the secure FTP sites are typically the result of one of the following:

1. Studies related to Generation Interconnection Requests
2. Studies related to Transmission Service Request
3. Models related to Generation Interconnection Process per FERC Order 845
4. Annual Transmission Expansion Plan
5. Other CEII information the TO wishes to distribute to customers

Please note that this request for a login to the FTP site(s) is for an individual and each person within an entity or organization who seeks access to the study reports and information must complete the form.

Upon receipt of this signed request form and the executed NDA(s) (or confirmation of existing NDA), LG&E/KU will review the request and make a determination as to whether or not the access can be granted. If granted, the requestor will receive an email from the FTP server with instructions for creating an account.
