

Business Practice #54: Early Termination of Service Agreements for Long Term Firm Point-to-Point Transmission Service

Policy Reference

Attachment A to PacifiCorp's Open Access Transmission Tariff (OATT), Form of Service for Long Term or Short Term Firm Point-to-Point Transmission Service, section 3.2, states "Service under this agreement shall terminate on such date as mutually agreed upon by the parties."

Definitions

No definitions other than those currently contained in the OATT are required for this business practice.

Purpose

The purpose of this business practice is to document under what circumstances PacifiCorp will allow the early termination of a Service Agreement for Long Term Firm Point-to-Point Transmission Service.

Practice

PacifiCorp will allow a customer to terminate a Service Agreement for Long Term Firm Point-to-Point Transmission Service under any of the following circumstances:

- 1. Transmission system improvements or upgrades were not required to accommodate the original transmission service request.
- 2. Transmission system improvements or upgrades were required and Transmission Customer reimburses PacifiCorp for all costs incurred for system improvements or upgrades that are in progress or have been completed.
- 3. Transmission system improvements or upgrades were required but no costs have been incurred by PacifiCorp for the system improvements or upgrades.

Any request to terminate must be made by a Transmission Customer as soon as practical but in no event less than 90 days prior the desired effective date of termination and must comply with the process set forth below.



Process

- 1. The customer must submit a written request, using Exhibit A to this Business Practice, referencing, among other things, the specific service agreement number, if known, the existing AREF, and the date on which the termination is requested to be effective.
- 2. PacifiCorp Transmission will review and process the request in accordance with the OATT timelines for new Firm Point-to-Point Transmission Service as follows:
 - If agreement to be terminated meets criteria (1) or (3) identified in the Practice section of this Business Practice (*i.e.*, no costs have been incurred by PacifiCorp to accommodate the service), PacifiCorp Transmission will approve the request within 30 calendar days of receipt of request and confirm the effective date of the termination.
 - If agreement to be terminated required PacifiCorp to incur costs for transmission system improvements or upgrades to accommodate service, PacifiCorp Transmission will notify the customer within 30 calendar days of receipt of request. On a case-by-case basis, PacifiCorp Transmission will consider such requests to terminate agreements where PacifiCorp has incurred costs in order to accommodate service, provided that PacifiCorp and the customer reach mutual agreement regarding reimbursement of costs incurred, consistent with criterion (2) identified in the Practice section of this business practice.
- 3. Upon approval of a request, PacifiCorp will modify, or request that the customer withdraw, the AREF as follows:

This termination form shall be used when making any written requests pursuant to the following provisions.
