Full EIM operations are scheduled to begin November 1, 2014, at which time the EIM will produce financially binding settlements, dispatch instructions and actual energy flows associated with EIM Transfers. Further, as discussed in PacifiCorp's webinar conducted September 30, 2014, PacifiCorp customers may begin using EIM systems and processes to submit operational data as early as October 3, 2014, and are required under PacifiCorp's OATT and EIM business practice, to submit such data beginning October 8, 2014. This will allow Transmission Customers an opportunity to fully explore and understand input systems prior to full EIM launch on November 1.
